



Photographic Competition and Exhibition 2018

Conditions of entry

COMPETITION ELIGIBILITY: The Competition is open to the general public. Participants are to be 16 years of age or older on the closing date of the submissions, and are to be residents of Malta.

IMAGE OWNERSHIP: Participants must have full rights of the entries submitted.

CERTIFICATION & PERMISSIONS: By virtue of submitting a photographic entry, the participant certifies the work as his/her own and permits the Organisers to reproduce all or part of the entered material free of charge for publication or display in all media and on the Floriana Local Council website . Participants personally assume responsibility for any claim arising out of the publication, exhibition or use of their photographic entries, as the Organisers assume no liability for any misuse of copyright / data protection and categorically disclaim any liability whatsoever.

INTELLECTUAL RIGHTS: The copyright of photographs entered in this competition remains with the entrant at all times.

NUMBER OF ENTRIES: Each participant may submit a total of four (4) images, in colour or monochrome. Participation in this photographic competition is free of charge.

SUBJECT MATTER: 'FLORIANA '

CLOSING DATE: Entries must be handed in or sent by post to the Floriana Local Council 15, Pjazza E.S. Tonna, Floriana FRN 1483, by not later than 15:30hrs on Wednesday 14th November 2018. No submissions will be accepted after the closing date and time.

PRINT SIZE: Prints must measure between a maximum dimension of 40cm x 30cm and a minimum dimension of 30cm x 20cm, edge to edge. Prints must NOT be mounted and must NOT have borders.

LABELLING OF PRINTS: Title of work, name and ID Card Number of participant must appear on the application form. An arrow indicating image orientation must be included. There should be no reference to the authorship on the photograph. Upon submission at the local council, entries will be numbered individually; the same number will be listed on the application form. This guarantees anonymity of work.

REJECTIONS: The Organisers reserve the right to reject any print prior to judging, giving a specific reason for such action.

ORGANISERS' LIABILITY: All submitted entries will be handled with care. The Floriana Local Council cannot accept liability for any loss or damage to any submitted entry, however caused.

JUDGING: All entries will be judged at the Floriana Local Council premises by a panel of three judges consisting of one Council member and two experienced photographers. The judging criteria will be:
i. Subject, ii. Composition, iii. Intelligent use of light and iv. Creativity.

POST JUDGING REJECTIONS: In the event that any selected or award winning entry is later found to have violated any of the conditions listed, the Organisers reserve the right to take any action they deem fit, including the withdrawal of the prize/s awarded. In such cases, the winning image will be declared null and the award left void.

AWARDS: A prize will be awarded to the first, second and third placed image by the Floriana Local Council. An exhibition with the best placed entries will be held during the yearly celebrations commemorating the liturgical feast of St. Publius on the 21st January 2019.

DATA PROTECTION: The Floriana Local Council collects contact information from the participants to enable communication between the Council and the participants. This data will be kept secure as specified in General Data Protection Regulations 2018.

ACCEPTANCE OF CONDITIONS OF ENTRY: Participation in the Photographic Competition and Exhibition 2018 organised by the Floriana Local Council, signifies full and unconditional acceptance of all the above conditions.
